<u>Course Description:</u> This course examines the problems that emerge when post-secondary education is provided on a mass scale. These problems include student disengagement and grade inflation, corporatization and the consumer model, and stress experienced by students and professors.

I expect that you will move beyond the course material, expanding and offering new ways of thinking about sociology that relate to our course.

Midterm (25%) and Final Examination (30%):

- Both examinations will be completed in-person, closed book
- They will be 2 hours in length
- They may include a combination of m/c, short answer, or essay style questions. A breakdown will be provided before each exam.
- They will consist of questions drawn from lectures, and all assigned material.
- The final exam will be held during the April examination period and the date and time will be set by the Registrar's Office.
- No devices or learning aids will be permitted in the exams

- o with the exception of students with approved accommodations that have spoken with the instructor and pre-made arrangements with SSD
- Students with a formally approved absence (through Academic Counselling) will be required to write a makeup exam on the date provided by the instructor following the original exam.
 - Please note, the course professor or teaching assistant(s) may not be available to respond to questions during the makeup exam.
 - O Students should also be aware that the make-up test will not necessarily be in the same format, be of the same duration, or cover the same material as the original test.
- Computer-marked multiple-choice tests and/or exams may be subject to submission for similarity review by software that will check for unusual coincidences in answer patterns that may indicate cheating.

If you are unsure of material, you will be given many opportunities to ask for support. It is up to you to take advantage of them.

Group Research Project (30% total):

Students will work in groups of 4-5. As a group, you will select an issue in higher education that you believe is essential to address. Using research and sociological support, you will design a research project that examines what the problem is, why it matters and seeks answers on how to address it.

- We will have a poster day in class on March 29 where your group will 'present' your work to your peers.
 - There are no extensions or late days for this work. Time will be given in class to work on this project throughout the term.
- A final report will be due at the beginning of class April 5th.
 - o late submissions without discussion with the instructor will result in a penalty of 10% / day for up to five days.

A more detailed outline will be provided on OWL to guide your thinking and decision.

Engagement (15%):

Learning is deeper and more meaningful when you are an active participant. Listening to someone 'lecture at you' is not enjoyable for anyone, so be prepared to be an active member of our community.

Opportunities for engagement will be offered each week in a variety of ways. You will also be involved in a detailed self-evaluation process. This will be taken into consideration when feedback and grades are provided. The goal is to create a community that is comfortable, supportive, and connected. If you have questions, I am here to support you.

It is expected in a third-year course that students will attend and engage in class consistently. Any absences or issues should be communicated to the instructor as soon as possible.

Contingency plan for an in-person class pivoting to 100% online learning:

In the event of a COVID-19 resurgence during the course that necessitates the course delivery moving away from face-to-face interaction, affected course content will be delivered entirely online, either synchronously (i.e., at the times indicated in the timetable) or asynchronously (e.g., posted on OWL for students to view at their convenience). The grading scheme will **not** change. Any remaining assessments will also be conducted online as determined by the course instructor.

Student Absences:

If you are unable to meet a course requirement due to illness or other serious circumstances, please follow the procedures below.

Assessments worth 10% or more of the overall course grade:

For assignments that are worth 10% and more, documentation (medical or otherwise) is required, it can *only* be collected by the student's Dean's Office Academic Counselling unit.

For work totaling 10% or more of the final course grade, students must provide valid medical or supporting documentation to their Home Faculty Academic Counselling Office as soon as possible.

Absences from Final Examinations:

Students must provide valid medical or supporting documentation to their Home Faculty Academic Counselling Office as soon as possible. Academic Counselling will determine eligibility to write a Special Examination (the name given by the University to a makeup Final Exam).

You may also be eligible to write the Special Exam if you are in a "Multiple Exam Situation" (e.g., more than 2 exams in 23-hour period, more than 3 exams in a 47-hour period).

Note: missed work can *only* be excused through one of the mechanisms above. Being asked not to attend an inperson course requirement due to potential COVID-19 symptoms is **not** sufficient on its own. Students should check the Western website to see what directives for Covid are to be followed. Western has been and will continue to follow directives established by the Middlesex-London Health Unit. That directive will state whether students should or should not come to campus/class and any other requirements (e.g., masks are mandatory). Please check on your own and do not email the instructor, the Department Undergraduate Advisor/Coordinator or the Faculty of Social Science Academic Counselling Office.

Use of the service is subject to the licensing agreement, currently between The University of Western Ontario and Turnitin.com (https://www.turnitin.com/).
