<u>Course Description:</u> This introductory course challenges commonly held assumptions about individual success, talent and merit. Students will be introduced to underlying patterns and important debates about the nature of power and inequality, and how they shape issues such as work, family, education, the economy, and the pursuit of justice.

Anti-requisite(s): Sociology 1020, Sociology 1020W/X, Sociology 1021E

Course Objectives and Learning Outcomes:

Upon successful completion of this course, students will be able to:

- Apply a social scientific perspective in explaining and examining social inequalities across institutions such as education, health, and employment.
- Recognize similarities and differences between sociological perspectives and the perspectives of other academic and non-academic ways of knowing.
- Evaluate sociological and individual explanations for patterns of inequality in society.
- Interpret the results of sociological studies conducted using qualitative and quantitative research methods.
- Apply multiple social theoretical perspectives to explain the causes and consequences of social change.

Course Material:

The required textbook for this course is:

Corrigall-Brown, Catherine. 2023. *Imagining Sociology: An Introduction with Readings*. **Third Edition**. Don Mills, ON: Oxford University Press.

Note: you can purchase either the physical book (\$119.35) or the e-book (\$72.00).

Other reading assignments may consist of an assigned course text journal articles, book chapters, and knowledge mobilization resources. Links to PDFs, websites, and library resources will be provided via Brightspace.

Communication:

Students are responsible for checking the course OWL Brightspace site (https://westernu.brightspace.com/d2l/login) on a regular basis for news and updates. This is the primary method by which information will be disseminated to all students in the class.

Method of Evaluation:

The evaluation methods described in the course outline are essential requirements for the course.

Attendance/Participation: 5%

In-class attendance is vital to your success in the course. The assigned readings serve as a common point of reference for establishing your knowledge and understanding; lectures are designed to provide you with tools and explanations for solidifying your grasp of the material. You will need both to successfully pass the exam.

Lectures also build mental stamina to follow long-form oral arguments, and they provide social and cognitive stimuli that enhances retention.

To incentivize engagement in these vital aspects of this course, your attendance will be recorded upon completion of a weekly attendance activity using the iClicker platform. Your attendance grade will be calculated as a proportion of your in-class attendances on Weeks 2, 3, 4, 5, 6, 8, 9, 10, 11, and 12. If you have an unexcused absence, you can make up the missed grade by attending Office Hours the following week. If you require an extended absence (two or more weeks) on medical or compassionate grounds, consult with me once the issue is resolved and we can discuss a fair solution for your grade.

Midterm Exam — 30%

The Midterm Exam will be administered in class on February 24. The test will consist of multiple-choice questions. All course materials covered prior to the midterm will be eligible for testing.

Students will be expected to arrive on time for the exam. Students who arrive later than 30 minutes past the start of the Midterm will not be admitted into the examination room.

Use of electronic devices and other written aids (notes, outlines, etc.) will not be permitted during the examination, unless otherwise stated. Students with an approved absence from the Midterm will be required to write a makeup exam during the **departmental Midterm make-up midterm exam period** (time and location TBA). The course professor or teaching assistant(s) may not be available to respond to questions during the makeup exam. Students should be aware that the make-up test will not necessarily be in the same format, be of the same duration, or cover the same material as the original test.

Final Exam — 36%

The Final Exam will be administered during the **Final Exam period**. The exam will consist of multiple-choice questions. A specific breakdown of these components will be provided prior to the exam.

As with the Midterm, use of electronic devices and other written aids (notes, outlines, etc.) will not be permitted during the examination unless otherwise stated. Students with an approved accommodations for the final exam will be required to write a makeup exam during the **departmental Final Exam make-up period** (Location TBA). The course professor or teaching assistant(s) may not be available to respond to questions during the makeup exam. Students should be aware that the make-up test will not necessarily be in the same format, be of the same duration, or cover the same material as the original test.

Note: Computer-marked multiple-choice tests and/or exams may be subject to submission for similarity review by software that will check for unusual coincidences in answer patterns that may indicate cheating. *This applies to quizzes, the midterm, and the final exam.*

Scholarly Skills Upgrade — 5%

This guided online quiz will consist of a set of tasks using modules developed by the Writing Support Centre. You will select from a series of modules that can help enhance your skills in academic reading and writing. You will then demonstrate your skills by responding to a series of questions (multiple choice and short answer) using the Tests & Quizzes tool on OWL. **This assignment will be due January 26 by 11:59pm**.

A 36-hour grace period will be allotted for students who encounter technical issues or minor illnesses, inconveniences, etc. After that, late submissions will receive deductions of 5% per day from the original deadline. Assignments submitted later than 6 days past the original deadline will receive a mark of zero. Students requiring academic accommodation for late or missed assignments beyond the allotted grace period must receive approval from Academic Counselling.

Mini Assignments — 12% x 2

There will be two Mini Assignments in the term, due **February 1 by 11:59pm** and **March 13 by 11:59pm** respectively. These assignments test students' abilities to interpret and apply key course concepts. You will use OWL to submit multiple choice and short answer responses to a series of questions. This will not only support students who benefit from evaluations beyond time-restricted multiple-choice test taking, it will also help build skills in critical reading and writing.

Students will be expected to complete these assignments independently, without the aid of AI software, and to complete all written components using their own words.

A 36-hour grace period will be allotted for students who encounter technical issues or minor illnesses, inconveniences, etc. After that, late submissions will receive deductions of 5% per day from the original deadline. Assignments submitted later than 6 days past the original deadline will receive a mark of zero. Plagiarism: Students must write their assignments in their own words. Whenever students take an idea from another author, they must acknowledge their debt both by using quotation marks where appropriate and by proper referencing such as footnotes or citations. Plagiarism is a major scholastic offence.

All required papers may be subject to submission for textual similarity review to the commercial plagiarism detection software under license to the University for detection of plagiarism. All papers submitted for such checking will be included as source documents in the reference database for the purpose of detecting plagiarism of papers subsequently submitted to the system. Use of the service is subject to the licensing agreement, currently between The University of Western Ontario and Turnitin.com (https://www.turnitin.com/).

Students are expected to retain all research notes, rough drafts, essay outlines, and other materials used in preparing assignments. In the unlikely event of concerns being raised about the authenticity of any assignment, your instructor may ask you to produce these materials; an inability to do so may weigh heavily against you. Computer-marked multiple-choice tests and/or exams may be subject to submission for similarity review by software that will check for unusual coincidences in answer patterns that may indicate cheating.

Copyright: Students may not record or distribute any class activity, including conversations during office hours, without written permission from the instructor, except as necessary as part of approved accommodations for students with disabilities. Any approved recordings may only be used for the student's own private use.

That directive will state whether students should or should not come to campus/class and any other requirements (e.g., masks are mandatory). Missed Tests and Exams: Students with an approved absence from an in-class test will be required to write a make-up test. The make-up test will not necessarily be in the same format, be of the same duration, or cover the same material as the original test. Course professors may not be available to respond to questions during the make-up test/exam slots.

Students with an approved absence from a final exam in December or April will be required to write a makeup exam known as a Special Examination. Permission to write a Special Examination may be granted on the basis of compassionate or medical grounds with appropriate supporting documentation provided to the student's Home Faculty Academic Counselling office.

Students who fail to write a make-up test or special examination will receive a grade of zero on that assessment.

No other make-up opportunities will be provided unless further academic consideration is granted by the student's Home Faculty Academic Counselling office.

Religious Accommodation: Students should review the policy for <u>Accommodation for Religious Holidays</u>. Where a student will be unable to write examinations and term tests due to a conflicting religious holiday, they should inform their instructors as soon as possible but not later than two weeks prior to writing the examination/term test. In the case of conflict with a midterm test, students should inform their instructor as soon as possible but not later than one week prior to the midterm.

Contingency plan for an in-person class pivoting to 100% online learning: In the event of a COVID-19 resurgence during the course that necessitates the course delivery moving away from face-to-face interaction, affected course content will be delivered entirely online, either synchronously (i.e., at the times indicated in the timetable) or asynchronously (e.g., posted on OWL Brightspace for students to view at their convenience). The grading scheme will **not** change. Any remaining assessments will also be conducted online as determined by the course instructor.
