<u>Course Description:</u> This course considers gender issues including the conceptualization of gender and how gender structures theory and research in Sociology as well as areas of social life such as class and change, demography, race and ethnicity, and health and aging.

Prerequisite(s): None

Anti-requisite(s): Sociology 2282 F/G

Course Objectives and Learning Outcomes:

- *Develop an understanding of gender as something that is a social construct.
- *To examine how gendered relationships are fundamental relationships of inequality.
- *To draw attention to how gender inequality remains structurally embedded in a systemic patriarchy.
- *To explore how gender inequality intersects with other bases of inequality such as race, ethnicity, Indigeneity, social class, sexuality, disability, age, etc.
- *To describe how gendered inequalities as social exclusion are differently expressed across different institutional domains.

Communication:

Method of Evaluation:

The evaluation methods described in the course outline are essential requirements for the course.

Midterm: Monday, February 24, 2025 In-class, 2 hours, No Aids allowed 25%

Written Reflection Assignment: Monday, March 10, 2025 3 pages, double-spaced 20%

MindTap Chapter Quizzes, Due Weekly Prior to Class

Final Exam: TBA, No Aids allowed 40%

Students are expected to attend all classes as part of the learning process. This is where ideas, concepts and theories are discussed and shared with the class in important dialogues. Students are expected to arrive on time and stay for the entire class. Also, students are expected to be respectful of each other and their Professor as they discuss various topics in the class.

Written Reflection:

The 3 page, double-spaced, submitted in class, reflection paper will require students to reflect on how gender has been socially constructed relative to your life. That is, what is it about gender that has enhanced, and or challenged your everyday life? This reflection will link to theory discussed in the course, data and research to earn your opinion.

Due: March 10th,2025 In-class, hard copy

For this assignment, students are expected to submit the assignment by the deadline listed. Should illness or extenuating circumstances arise, students are permitted to submit their assignment up to 48 hours past the deadline (March 12, 2025) without academic penalty. Should students submit their assessment beyond 48 hours past the deadline, zero will be the mark that the student attains.

Instructors are permitted to designate one assessment per course as requiring supporting documentation to receive academic consideration. For this course the following assessments have been designated as requiring supporting documentation. Midterm February 24, 2025 and Final Exam TBA

All papers submitted for such checking will be included as source documents in the reference database for the purpose of detecting plagiarism of papers subsequently submitted to the system. Use of the service is subject to the licensing agreement, currently between The University of Western Ontario and Turnitin.com (https://www.turnitin.com/).

Students are expected to retain all research notes, rough drafts, essay outlines, and other materials used in preparing assignments. In the unlikely event of concerns being raised about the authenticity of any assignment, your instructor may ask you to produce these materials; an inability to do so may weigh heavily against you.

Computer-marked multiple-choice tests and/or exams may be subject to submission for similarity review by software that will check for unusual coincidences in answer patterns that may indicate cheating.

Copyright: Students may not record or distribute any class activity, including conversations during office hours, without written permission from the instructor, except as necessary as part of approved accommodations for students with disabilities. Any approved recordings may only be used for the student's own private use.

Missed Tests and Exams: Students with an approved absence from an in-class test will be required to write a make-up test. Students with an approved absence from a final exam in December or April will be required to write a makeup exam known as a Special Examination. Permission to write a Special Examination may be granted on the basis of compassionate or medical grounds with appropriate supporting documentation provided to the student's Home Faculty Academic Counselling office.

Students who fail to write a make-up test or special examination will receive a grade of zero on that assessment. No other make-up opportunities will be provided unless further academic consideration is granted by the student's Home Faculty Academic Counselling office.

Where a student will be unable to write examinations and term tests due to a conflicting religious holiday, they should inform their instructors as soon as possible but not later than two weeks prior to writing the examination/term test. Contingency plan for an in-person class pivoting to 100% online learning: In the event of a COVID-19 resurgence during the course that necessitates the course delivery moving away from face-to-face interaction, affected course content will be delivered entirely online, either synchronously (i.e., at the times indicated in the timetable) or asynchronously (e.g., posted on OWL Brightspace for students to view at their convenience). The grading scheme will **not** change. Any remaining assessments will also be conducted online as determined by the course instructor.
