Course Description:

Children born in rich and poor families have diverging destinies, with markedly different socioeconomic and family trajectories. This course will describe class disparity in children's family life, document the outcomes for children in the two groups, and identify social mechanisms contributing to class inequities.

Prerequisite(s): Registration in the third year or above.

Unless you have either the prerequisites or written special permission from your Dean to enroll in the course, you may be removed from this course and it will be deleted from your record. The decision may not be appealed. You will receive no adjustment to your fees in the event that you are dropped from a course for failing to have the necessary prerequisites.

Anti-requisite(s): Soc 3365 F/G taught in 2020/21

Course Objectives and Learning Outcomes:

*Gain insight about patterns and trends in socioeconomic inequalities for children.

*Identify the social mechanisms contributing to socioeconomic inequalities for children.

*Recognize how economic socio-cultural and behavioral factors work together to generate family inequalities by race, ethnicity, and nationality.

Course Material:

Course materials will be accessed through Brightspace and include academic articles accessed through Western Library.

Communication:

Students are responsible for checking the course OWL Brightspace site (<https://westernu.brightspace.com/d2l/login>) on a regular basis for news and updates. This is the primary method by which information will be disseminated to all students in the class.

Method of Evaluation:

The evaluation methods described in the course outline are essential requirements for the course.

Attendance and Participation: 10%

This involves attending each class and contributing to the class dialogue in useful and with informed viewpoints. It means coming to class on time and staying the duration of the class.

Midterm Exam: 30% In-class, no aids, 2 Hours

Students are expected to retain all research notes, rough drafts, essay outlines, and other materials used in preparing assignments. In the unlikely event of concerns being raised about the authenticity of any assignment, your instructor may ask you to produce these materials; an inability to do so may weigh heavily against you.

Computer-marked multiple-choice tests and/or exams may be subject to submission for similarity review by software that will check for unusual coincidences in answer patterns that may indicate cheating.
